Background

The European Year 2011 is coming closer. The European Commission is organizing a first policy debate on the Year on December 16, 2009 in Brussels inviting stakeholders to discuss challenges and opportunities of the Year: Maros Sefcovic, Commissioner for Education, Training Culture, Odile Quintin, Director General and Marian Harkin, Member of the European Parliament will discuss with 500 representatives from volunteer organisations, academia, public authorities and companies the direction the European Year of Volunteering 2011 should take.
